Sub.: Disclosure of reasons for delay in submission of Financial Results for the Quarter and Year ended 31st March, 2021, pursuant to the SEBI Circular CIR/CFD/CMD1/142/2018 dated 19th November, 2018

Dear Sir/Madam,

In terms of Regulation 33(3) of the SEBI (LODR) Regulations, 2015 read with SEBI Circular No. SEBI/HO/CFD/CMD1/P/CIR/2021/556 dated April 29, 2021, Rollainers Limited (the "Company") is obliged to submit and/or publish the financial results for the Quarter and Year ended 31st March, 2021 on or before 30th June 2021. However, the Company is not in a position to publish the said results in a timely manner. Therefore, in compliance with the SEBI circular dated 19th November, 2018, the Company would like to furnish the reasons for delay in publishing of financial results as under:

Due to the restrictions imposed by the Government on opening of private offices and on travelling of non-essential service staff due to Covid Pandemic (2nd Wave) and also on account of consolidation of account of our subsidiary companies, our employees as well as the statutory auditors along with their audit staff were unable to attend the work places. As a result, we are unable to file our quarter and yearly standalone and consolidated financial results for the year ended March 31, 2021 on or before the stipulated date i.e. June 30, 2021.

Further, we would like to inform you that we have already intimated the stock exchange vide Ref No. RTL/BSE/NSE/2021-22 dated 22nd June 2021 about the Board Meeting which was scheduled to be held on 30th June 2021 and dated 30th June 2021 about the postponement of the Board Meeting which is now rescheduled to be held on 15th July 2021 to consider, approve and take on record the Standalone and Consolidated Audited Financial Results of the Company for the Quarter and Year ended 31st March, 2021.

It is also informed that due to the second wave of Wuhan Virus pandemic (COVID-19), the governance become difficult and cumbersome for the Corporates to manage. Despite this, we have tried our best to follow the compliances in true letter and spirit.

In view of above you are hereby requested to condone the delay and provide relaxation from penal provisions for and on account of delay in submission of results.

We request your good office to consider our submission favourably and oblige.
